The purpose of this RFQ is to select a vendor who can provide reliable and high-quality equipment to meet the organization's meteorological monitoring needs.

General Terms & Conditions:

- The quoting firm must be FBR(Pakistan)-registered, comply with tax laws (sales & income Tax), and be an active taxpayer's list.
- Conditional/incomplete quotations or having overwriting/interlineations will not be accepted.
- The quoted prices should be valid for 90 days from the date of tender opening, prices must be inclusive of all costs.
- No quotation shall be received at all after the deadline specified i.e., January 24th, 2024, till 11:00. The bidders need to ensure to submit their bids by this time.

Delivery, Installation, and Completion Period:

- Items must be supplied as per the agreed delivery schedule.
- The delivery schedule starts from the date of issuance of work order by Inara Technologies.
- In the event of extended delay beyond 30 days, the supply order may be cancelled and in the event of cancellation of the supply order the earnest money will be forfeited.

Scope of Supply

- The bidder shall supply and commission all items as per specifications in "Annexure (A & B)".
- The quantity of items may vary based on project requirements and funding availability. Work items and quantities may be adjusted, with payments following approved rates and the actual completion specified in the supply order.

Bid Prices and Quoting:

- The supplier is required to quote its bid/charges for the supply of each item.
- Unit prices must be indicated inclusive of all costs (taxes, duties, transportation) along with total prices of goods/services in Pak Rupees only. Payment of any Government taxes and duties levied before opening of bids shall be the sole responsibility of the bidder subject to prevailing regulations.

Purchaser's Rights

Inara TECHNOLOGIES (PVT) LIMITED maintains the authority to modify item specifications and quantities. This flexibility absolves the company of any financial liability towards bidders. It is pertinent to note that only the head office of Inara Technologies located at [] is authorized to collect the bids.

Conversing

Unsolicited advice/clarification and any personal contact at any stage of evaluation of bids are strictly prohibited and may lead to disqualification.

Performance Guarantee

The supplier must ensure the supply, commissioning, and provide free repair services, if needed, during the one-year performance guarantee period after system commissioning through the OEM's warranty channel.

Delivery, Installation, and Completion Period

The bidder must adhere to the delivery schedule from the work order issuance date. A 0.01% daily penalty may apply for late delivery. After 30 days, orders may be cancelled, and earnest money forfeited.

Mode of Payment

No advance payment shall be admissible to any firm against any supply order. No such demands shall be entertained and failure to execute work against supply order will result in forfeiture of earnest money.

Payment shall be made through cross as per the schedule below:

- 90% on completion of work and successful inspection of the deliverables.
- 10% after completion of one year.
- Quotation for mode of payment on cash will provide written guarantee of the replacement of gadgets if found faulty.

Evaluation Criteria:

The quotations will be evaluated on the basis of; lowest price quoted, general specifications met and compliance to the terms and conditions of the procuring agency.

Guarantee/Warranty

The required warranty period of one year should be confirmed through a valid legal document. The shortlisted supplier will be responsible for arranging any spare part or repairing any damage that occurs during the period of one year, in case of IT devices.

The representative of Inara Technologies Pvt. Ltd may inspect, reject, or demand alterations or replacements to items or services under the contract at any time before its expiration. The findings will be conclusive except for the defects detected at a later stage or fraud.
